**CHARTER TOWNSHIP OF WATERFORD  
ORDINANCE NO. 2017-001  
DUTY TO CONTROL WEEDS AND GRASSES AMENDMENT**

An Ordinance to amend the Waterford Charter Township Code by revising the existing regulations regarding permitted height for control of weeds and grasses.

THE CHARTER TOWNSHIP OF WATERFORD ORDAINS:

**Section 1 of Ordinance**

That Section 9-173, Definitions, in Article 5, Vegetation Control, In Division 1, Generally, of Chapter 9, Health and Sanitation of the Waterford Charter Township Code of Ordinances is hereby amended to read as follows:

***Uncontrolled Growth*** A height greater than ~~ten (10)~~ **eight (8)** inches.

**Section 2 of Ordinance**

That Section 9-182, Duty to Control Weeds and Grasses, in Article 5, Vegetation Control, In Division 2, Noxious Weeds, of Chapter 9, Health and Sanitation of the Waterford Charter Township Code of Ordinances is hereby amended to read as follows:

Sec. 9-182. Duty to control weeds and grasses

(a) It shall be unlawful for the owner, agent or occupant of lands to permit the growth of noxious weeds of any height upon any property in the Township.

(b) It shall be unlawful for an owner, occupant, or agent with rights or responsibilities for maintenance of a zoning lot or parcel to permit the uncontrolled growth of weeds and grasses **to a height greater than eight (8) inches** when such uncontrolled growth occurs on any of the following lands:

1. Subdivided land on which buildings have been erected on at least sixty (60) percent of the zoning lots within the boundaries of the subdivided land.
2. Zoning lots along improved streets in common usage, to a depth of one hundred sixty five (165) feet or the depth of the zoning lot, whichever is the lesser.

**Section 3 of Ordinance**

Should any section, subdivision, sentence, clause or phrase of this ordinance be declared by the Courts to invalid, the same shall not affect the validity of the Ordinance as a whole or any part thereof other than the part as invalidated.

**Section 4 of Ordinance**

This Ordinance shall take effect immediately upon publication.

**7. NEW BUSINESS**

**7.1 Approval of School Liaison Contract with Waterford School District.**

The following memo was received by Police Chief Underwood.

For many years the Waterford Township Police Department and the Waterford School District have enjoyed an outstanding relationship, rooted in cooperation and mutual respect. We have participated in grant funded programs as well as educational and community focused events.

One of our most important initiatives has been the Police-School Liaison Program. This has allowed us the opportunity to have police officers present in the schools, on a daily basis, throughout the entire school year. Through this program, we can reach students early and often to help guide and support them. Our presence in the schools provides a valuable resource for students, parents, teachers and administrators so we can collaborate and provide a safe successful learning environment.

The Police Department and Waterford School District administrators have mutually reached the following agreement. The agreement provides for four (4) police officers to act as school liaison officers; one (1) in each high school and one (1) in each middle school. The school district has agreed to pay for 2.5 (FTE) of the four (4) officers assigned to the schools.

The cost breakdown is as follows:

Police Officer (FTE)	\$130,539.86	X	(4)	=	\$522,159.44
School District Cost	\$130,539.86	X	(2.5)	=	\$326,349.65
Township Cost	\$130,539.86	X	(1.5)	=	\$195,809.79

It should also be noted that any overtime or additional costs incurred will be billed to the Waterford School District at the current hourly rate including benefit costs.

The attached contract will remain in effect through June 30, 2017, and will automatically renew for each school year, absent a notice of non-renewal that must be submitted by July 31st, of the year the next renewal term would commence.

We are requesting that this honorable body approve the execution of the attached contract based on its content and the information set forth above.

**7.3 2017-2018 DPW Pavement Repairs**

The following memo was received from William A. Fritz, DPW Director.

The purpose of this submittal is to seek Waterford Township Board of Trustees approval to award construction contracts for pavement repairs throughout the Township. These repairs will be at locations where DPW activities have caused damage to existing roads, pathways, and sidewalks. Bids for this work were received on January 31<sup>st</sup>. We are requesting that the Board award two contracts as described in the attached memo from Dan Stickel, DPW Engineering Superintendent.

The purpose of this submittal is to seek Waterford Township Board of Trustees approval to award a construction contract for asphalt resurfacing of Civic Center Drive. Bids for the same services were very recently taken by the Road Commission for Oakland County (RCOC), with Pavex being awarded the contract. We therefore request the Board utilize the Government Contract provision of the Waterford Township Procurement Policy and award a contract to Pavex for asphalt pavement resurfacing services.

Attached is a memo from Dan Stickel, DPW Engineering Superintendent, describing how we came to conclude that most of the roadway asphalt pavement has deteriorated to the point of requiring being milled and overlaid (Exhibit I). Dan's memo also includes the following:

- Letter from Pavex honoring the terms and conditions of the RCOC Contract,

- Quote for an addition to the project scope to include a new product, J-Band.
