RE: MICHIGAN FREEDOM OF INFORMATION ACT(FOIA) REQUEST FOR NON-EXEMPT PUBLIC RECORDS

Dear Waterford Police Dept FOIA Coordinator, et al,

PLEASE BE ADVISED that this is a formal written Michigan Freedom of Information Action Request(demand) under the Michigan FOIA Act/Statute, MCL 15.231 et seq for the immediate release/disclosure of existing non-exempt Public Records that the Waterford Police Dept retains/possesses and has legal duty to disclose, based upon the following:

(1) That the Waterford Police Dept FOIA Coordinator and/or any other Waterford Police Dept Person/Employee/Respondent to deny or release said requested Michigan Public Records, and is defined as a "Public Body", per MCL 15.231

(2) That I/Requester is a "Person" subject to request/obtain/demand a copy of a requested Michigan Public Record from said Public Body, per MCL 15.231.

(3) That I/Requester request a copy of any/all unedited 911 audio recordings from unknown caller(s) to/between the Waterford Police Dept Dispatcher for the date of MARCH 22,2021 at 10-10:30 PM reporting a possible hit-and-run of pedestrian by unknown vehicle in Waterford Mich in area of Dixie Hwy and Telegraph Rd.

(4) That I/Requester request a copy of any/all unedited audio/video dashcam and/or bodycam from the Unknown Waterford Police Officer(s) and Waterford PD Patrol Car(s) that responded on MARCH 22,2021 at approximately 10-10:30 PM to investigate the reporting a possible hit-and-run of pedestrian by unknown vehicle in Waterford Mich in area of Dixie Hwy and Telegraph Rd.

(5) That I/Requester request a copy of any/all unedited private security surveillance videos from the businesses that voluntarily provide security that was collected/obtained by Unknown Waterford Police Officer(s) that responded on MARCH 22,2021 at approximately 10-10:30 PM to investigate the

reporting a possible hit-and-run of pedestrian by unknown vehicle in Waterford Mich in area of Dixie Hwy and Telegraph Rd.

(6) That I/Requester request a copy of any/all search warrants obtained by Unknown Waterford Police Officer(s) from Unknown Judge/Magistrate to seize/open this Requester's cell phone and vehicle on MARCH 22-23,2021 to investigate the reporting a possible hit-and-run of pedestrian by unknown vehicle in Waterford Mich in area of Dixie Hwy and Telegraph Rd.

(7) I/Requestee will provide blank CDs, DVDs, Flashdrives etc that may be necessary to promptly provide a copy and transfer/convert to blank CDs, DVDs, and Flashdrives for I/Requestee to play, via, DVD/CD Player for TV Screen and CD Player. Further, This I/Requestee requests that he receive a detail/itemized list of any/all Public Records provided to I/Requestee).

(8) That I/Requester claims/states that said demanded Public Records would NOT be exempt, and would unambiguously be released by court-ordered disclosure based upon being arbitrarily and capriciously denied by the Waterford Police Dept. FOIA Coordinator(or Information Officer).

WHEREFORE, I/Requestee requests that this Waterford Police Dept FOIA Coordinator(or Information Officer) honors/grants my Michigan Freedom of Information Act Request(FOIA Request) by promptly collecting and providing me with said Requested Information and Public Records/Information promptly within FIVE(5) Business Days, or I will deem my Request under the Michigan FOIA arbitrarily and/or capriciously denied and will moveforth by filing a meritorious Complaint For Civil Action for Court-Ordered disclosure, and monetary award pursuant to MCL 15.240 et seq. as all circumstances should dictate and Justice would so demand.

(3) That I/Requester request a copy of any/all unedited 911 audio recordings from unknown caller(s) to/between the Waterford Police Dept Dispatcher for the date of MARCH 22,2021 at 10-10:30 PM reporting a possible hit-and-run of pedestrian by unknown vehicle in Waterford Mich in area of Dixie Hwy and Telegraph Rd.

(4) That I/Requester request a copy of any/all unedited audio/video dashcam and/or bodycam from the Unknown Waterford Police Officer(s) and Waterford PD Patrol Car(s) that responded on MARCH 22,2021 at approximately 10-10:30 PM to investigate the reporting a possible hit-and-run of pedestrian by unknown vehicle in Waterford Mich in area of Dixie Hwy and Telegraph Rd.

(5) That I/Requester request a copy of any/all unedited private security surveillance videos from the businesses that voluntarily provide security that was collected/obtained by Unknown Waterford Police Officer(s) that responded on MARCH 22,2021 at approximately 10-10:30 PM to investigate the

reporting a possible hit-and-run of pedestrian by unknown vehicle in Waterford Mich in area of Dixie Hwy and Telegraph Rd.


