Callahan) instead of 1" x 2" welded wire mesh squares proposed, pull-up top, both doors open at front and will be hinged and include handles and latches for security. - a. Director's Report: Tori Heglin reporting for Alison Swanson
 - i. Upcoming plans for a tree to be planted by Jerry (past employee) and Barbara Flatt as a 60th Wedding anniversary celebration. The family has made arrangements for the tree (on approved list, Autumn Blaze Maple) and contractor.
 - ii. Caretaker house update: Painted, carpet pulled out, deck porch remediated. The caretaker position will be posted when house is ready.
 - iii. There are plans to relocate the department's Town Hall staff over to the Recreation Center in 2022.
 - iv. Budget: Township Board to approve in December. Parks and Recreation Department is requesting three additional part-time, permanent positions. The schedule for the one pending position designated for Hess Park will

be determined by our current needs. We hope to be able to staff two farmers at our busiest times when patrons are many and the staff is attending to animal tours and havrides.

b. Parks and Recreation Programs: Tori Heglin
